Types of membership

- ★ **ENSHPO Member:** The Member Association will select a representative to attend and contribute to the ENSHPO Network Assembly (NA). They will be able to elect the Executive Committee, and contribute to ENSHPO's decisions, strategic plan, and work.
- ★ **Candidate Member:** Temporary status while membership is considered. Representatives will be invited to a Networking Assembly meeting.
- ★ **Dialogue Partner:** Partnership open to any international professional organisation or network that shares a mutual interest with ENSHPO.
- ★ **Associate:** Individual, private, or research organisation or network whose expertise is usually needed for a particular purpose at ENSHPO, for a specific length of time.

Meetings

ENSHPO members meet twice a year at locations around Europe, in spring and in autumn time. Typically the meetings are held on a Friday afternoon and Saturday morning.

The meetings consist of an update about ENSHPO's key projects; we also invite interesting guest speakers from the European Agency, and other DSH professional networks. Meetings are held in English due to the multilingual nature of the network.

ENSHPO members take it in turn to host a meeting, and pay for the meeting venue, refreshments, and usually the evening dinner. Attending representatives will be expected to arrange their own travel and accommodation arrangements, and cover their own costs to attend the meetings.

There is usually a dinner organised on the Friday evening for an opportunity to network with the other members.
