WEBINAR "SAFE DAY". MAY 4TH 2023, 14.00-15.30 (CEST)

In June 2022, the 110th **International Labor Conference** adopted a resolution to include the principle of a safe and healthy working environment in the framework of Fundamental Principles and Rights at Work (FPRW) of the **International Labor Organization (ILO)**
