Therefore, our organisation is open to all and for all.





Risk assessments are a valuable tool in the toolkit of a OSH professional, however require knowledge, resource and time which, in this fast world of work, is often at a minimum. EU-OSHA's Online interactive Risk Assessment (OiRA) tools assist employers in the identification and management of safety and health hazards in the workplace, covering specific sectors, languages and countries and they are freely accessible.

The campaign materials feature six generic tools that are able to fit most micro and small enterprises working in different industries. 

On the 17th of January 2024 the Hungarian OSH Academy (MMA) has organised an event, moderated by Ildikó Pálfy member of MMA, included four presentations in its program. One key element of the program was, that András Gedeon, founding member of the Hungarian Academy of Occupational Safety and Health (MMA) talked about the challenges faced by occupational safety representatives and the institutions training them.





Safety representatives are tasked with the responsibility of representing the interests of employees in matters concerning occupational safety and health. They serve as a crucial link between the management and the workforce, advocating for safe working conditions and promoting a culture of safety within the organization.

The role of safety representatives has a profound impact on the safety culture within an organization. A positive safety culture is characterized by open communication, active employee participation, and a shared commitment to safety at all levels of the organization. Safety representatives play a pivotal role in shaping and nurturing this culture through their actions and interactions with employees and management.

Based on a December 2023 Survey, MMA has pointed out some critical areas, where safety representatives are struggling in Hungary.

Findings:

- Only 61,5% of employers provide the regulated resources to safety reps.
- 11,5% of safety reps reported, that they have been obstructed by their employers during their activities
- 70% of safety reps were never used their law given right about OSH experts to support them in their duties.
- 37,5% reported they have never been contacted by employers nor employees to address OSH matters.
- 44% of OSH representatives were never involved in OSH risk assessment process at their workplaces.
- Only 22% of employers consult regularly with OSH representatives.
- 38,5% of safety reps were never contacted by employers nor employees in OSH matters
